CASE ON SUDDEN REQUIREMENT

Crystal Taylor v A Novo (UK) Ltd [2013] was considered in Paul v Wolverhampton [2024, UKSC]. In three conjoined cases, the claimants sustained psychiatric injury after experiencing the traumatic death of a loved one, following alleged clinical negligent misdiagnosis of the primary victim's condition.

The gap in time in these cases between the defendants' acts and the deaths ranged from months to more than a year.

It was held that Taylor v Novo was binding authority for the proposition that no claim could be brought in respect of psychiatric injury caused by a separate horrific event that was significantly removed in time from the original negligence, accident or a first horrific event.

During speeches in SC, there was a discussion about historical instances of negligence in medical treatment/care. They indicated a viewpoint that accidents, which are sudden and unforeseen events, are distinct occurrences that do not have a direct comparison in the medical field. Further, the duty of a medical professional does not extend to protecting a patient's family and friends from experiencing the upsetting results of treatment.

Key point

To be recoverable, psychiatric illness must be caused by an immediate shock not a delayed one

Facts

- C had been exposed to asbestos but did not know until he was informed by his doctor 30 years later
- The risk of developing a health condition led C to worry so much that he developed clinical depression
- C argued that Page v Smith applied as even though no physical injury had resulted from exposure to asbestos, physical injury was reasonably foreseeable

Held (House of Lords) C's claim was rejected

Lord Hoffmann

- The current case can be distinguished from Page v Smith on the basis that C's illness was not caused by the immediate effects of a past traumatic event: it was triggered by his awareness of the risk of developing a condition: [95]
- Furthermore, in Page v Smith, the event causing the risk of physical and psychiatric injury was one and the same (being the accident) but here the risk of physical injury was caused by exposure to asbestos: [96]
